ORCA 100 Rules and Tariff

Rules, regulations, and charges outlined herein supersede those outlined in previous documents issued by Orcas Island Freight Lines, Inc.

### **100 Governing Provisions**

Except where specific exceptions are made hereto, shipments moving via Orcas Island Freight Lines, Inc. shall be subject to the National Motor Freight Classification (NMF100 Series), ORCA 100 Rules and Tariff, and individually negotiated pricing agreements and contracts between Orcas Island Freight Lines and its customers.

1. The National Motor Freight Classification (NMFC) may be reference from time to time herein or in other ORCA written documents as NMFC, NMF100, or Class IT (web based NMFC).
2. Orcas Island Freight Lines, Inc. may be referenced from time to time herein or in other written documents as ORCA, Orcas Freight, or carrier.
3. Upon written request, carrier will provide its customers and shippers with copies of all applicable rules and rates. Rules and accessorial charges are available on the carrier's website.

### **105 Operating Rights and Carriers**

Orcas Island Freight Lines MC#111115 / CC 16890

Otherwise herein defined as Carrier, are authorized to operate as a motor carrier by motor vehicle, in interstate and intrastate transporting general commodities (except for Prohibited or Restricted Articles, see 780).

### **110 Abbreviations and Definitions**

Business Days: Monday through Friday, excluding holidays.

Business Hours: 8 am to 5 pm, excluding Saturday, Sundays, and Holidays

Carrier: Orcas Island Freight Lines, Agent Carriers

Carrier's Equipment: Any motor truck or other self-propelled highway vehicle, trailer, or any combination of such highway vehicles, operated by carrier.

COD: Collect on Delivery

Consignee: The person, firm, or company shown on the Bill of Lading as the party to whom the property is physically delivered to.

Density: For the purpose of determining NMFC density-based classifications, the dimensions of articles will be calculated in accordance with section 8, Item 110, NMFC 100 Series.

FAK: Freight of all kinds

Holidays:

New Year's Day (January 1<sup>st</sup>)

Memorial Day (last Monday in May)

Independence Day (July 4<sup>th</sup>)

Labor Day (1<sup>st</sup> Monday in September)

Thanksgiving Day and the Day after

Christmas Eve (December 24<sup>th</sup>) and Christmas Day (December 25<sup>th</sup>)

Household Goods: Used household goods or personal effects (not for resale), such as clothing, furniture for personal and/or residential use.

Interline carrier: Connecting line carrier that may provide origin and/or destination service, e.g. Orcas Island Freight Lines is a Interline Carrier for most major freight carriers.

Intrastate – Origin and destination points reside within the same state

Interstate- Origin and destination points do not reside within the same state.

LTL: Less than Truckload.

Minimum: The minimum charge for a single shipment from one consignor to one consignee on one bill of lading.

NMF: National Motor Freight Traffic Association, Inc.

NMFC: National Motor Freight Classification.

ORCA: Orcas Island Freight Lines, Inc.

Palletized shipment: A shipment tendered to and transported on pallets.

Power equipment: Any gasoline, diesel, electric or gas driver equipment including electric powdered cranes and lift truck equipment.

Residence: shall apply to the entire premises which the occupant owns, leases, rents or occupies as a dwelling for a living, except it will not apply to that portion of the premises where commercial or business activity is conducted that involves the sale of services, products or merchandise to the walk-in public during normal business hours.

Shipper: The person, firm, or company shown on the Bill of Lading as the Consignor or Shipper of the property received for transportation.

Tariff: Published rates, accessorial charges and rules.

Third Party: Any party other than the Consignee or Shipper identified on the Bill of Lading.

TL: Truckload.

### **125 Service Standards**

Freight shall be delivered upon reasonable dispatch. Appointment times and notations such as “must deliver by” on the bill of lading are insufficient to alter the reasonable dispatch standard unless previously requested and agreed to.

### **150 Airport pick-ups**

\$150.00 per shipment. Applies on any shipment picked-up at an airport.

### **160 Hazardous Materials (HAZ-MAT)**

All shipments containing Hazardous Materials and requiring a positive notation in the Hazardous Materials column on the Bill of Lading are subject to an additional fee of \$100.00 per shipment.

### **200 Packaging & Debris Removal**

\$75.00 per (48x48) pallet will apply when ORCA removes packaging or debris following a delivery.

In no event will carrier remove packaging or debris that is hazardous or requires special disposal such as e-cycling, hazardous materials, or any other deemed solely by carrier as non-standard packaging and debris.

### **560 Hourly Fee**

When Carrier provides services on a “per hour” basis, the fee will be \$250.00 per man-hour with a one-hour minimum.

### **574 Liftgate Pickup or Delivery**

All standard deliveries made on Orcas, Lopez or Shaw Islands will be completed with a liftgate truck. No extra charge will be applied for providing a liftgate truck.

Driver safety considerations limit eligible handling units to the following:

Note 1: Handling units exceeding 4'x8' is considered overlength

Note 2: Handling units exceeding 2500# is considered overweight

A rate of \$250 per hour will be applied for overlength and overweight deliveries which require a forklift.

### **578 Long Articles**

-Articles longer than 12' in length but less than 16' are subject to a \$100 overlength fee per shipment

-Articles longer than 16' in length but less than 20' are subject to a \$175 overlength fee per shipment

-Articles longer than 20' in length or greater are subject to a \$200 overlength fee per shipment

### **658 Notification Prior to Delivery**

Recognizing that many residents on Orcas, Lopez and Shaw Islands do not live there permanently, carrier will always attempt to notify residential consignees prior to delivery. No fee will be charged for notification.

### **755 Interline Agreements**

This tariff is the sole and complete tariff for Orcas Island Freight Lines, Inc (SCAC designation: ORCA). Therefore, we do not subscribe to, nor participate in any other ICC or intrastate tariffs or discount schedules. Interlining carriers are requested to incorporate the applicable portions of this document into their regular freight rating systems to avoid errors.

### **780 Prohibited or Restricted Articles**

- Articles of extraordinary value.
- Any shipments which contain articles requiring temperature control or protection from heat and cold.
- Any shipments which contain articles prohibited by law.
- Any shipments which may damage equipment or other freight.
- Bank bills
- Biological products.
- Blood, blood related components and products.
- Carbon black
- Cigarettes and cigars.
- Coins and currency.
- Corpses.
- Dangerous when wet.
- Explosives.
- Fireworks.
- Improperly packaged freight.
- Jewelry, other than costume or novelty.
- Live animals or fish.
- Medical waste.
- Museum exhibits or articles of antiquity.
- Original works of art.
- Platinum, gold, silver, and other precious metals.
- Poison gas
- Postage stamps
- Precious stones
- Radioactive materials

### **910 Storage**

Recognizing that many residents on Orcas, Lopez and Shaw Islands do not live there permanently, carrier will do their best to deliver in a timely manner. \$50 storage fee per pallet space per week will incur after 14 days.

## Application of Rates

1. Are in dollars per pounds, unless otherwise stimulated therein.
2. Include one pickup and/or delivery for each shipment.
3. Including loading into and unloading from carrier's equipment.

Schedule of delivery fee by island and zip code. All delivery fees are in addition to the tariff rate.

\*NOTE: Olga (on Orcas Island), Blakley Island, and Waldron Island have the same zip code 98279, however, different rates are in place for each location.

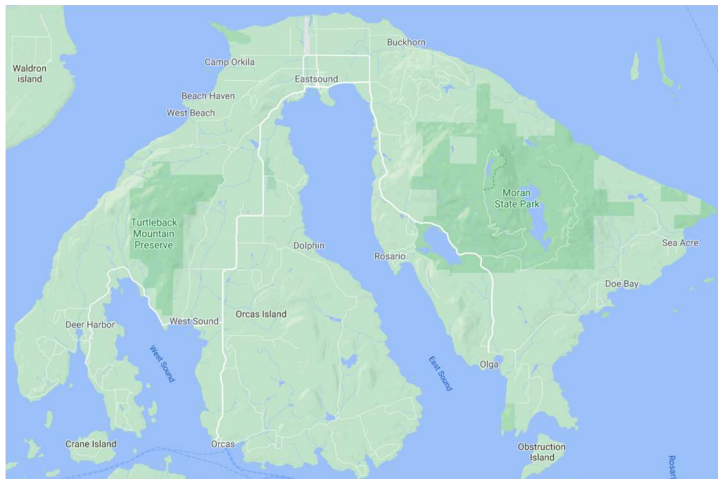

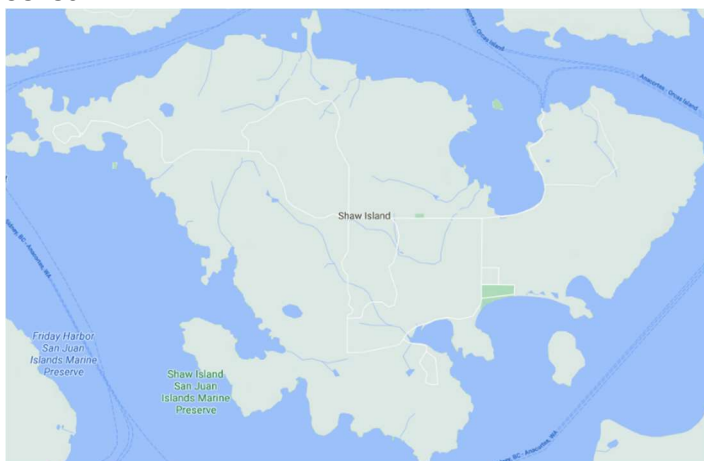

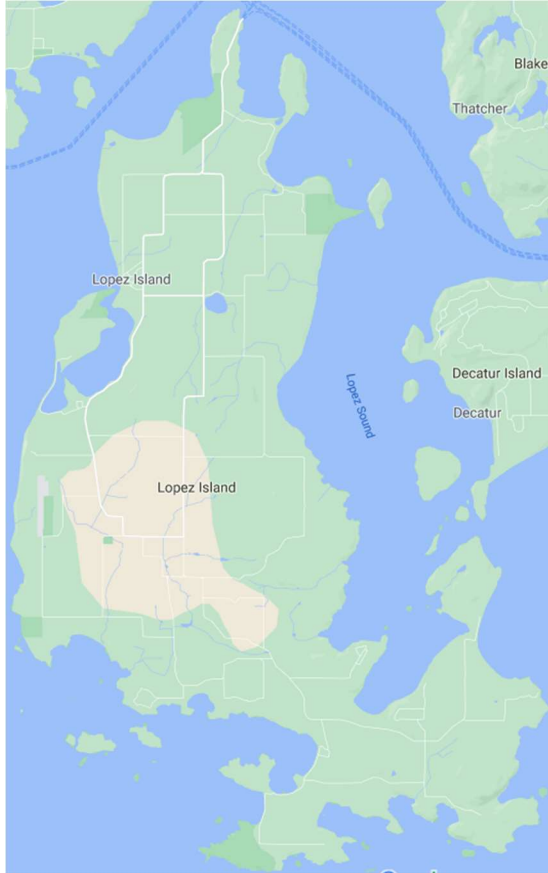
